2. Request Pikitup to confirm Pick up spots for collection of refused bags
3. There is a proposal for "Adopt-A-Spot" whereby communities, NGOs Companies would take responsibility for the upkeep of the area. We need policy guideline on this matter on how it can be taken forward.
4. People with stolen waste-bins have been advised to make individual request and comply with PIKITUP Request. Urban inspector will assist.
5. Street lights have been vandalised in Poortjie
6. An incomplete structure in Vlakfontein serves as a hideout for criminals must be demolished or completed.

Activities:

1. A Re Sebetse Stakeholders Forum is scheduled for 14 May 2019 where additional spots will be submitted by stakeholders.
2. Dry Run is scheduled for Thursday 15 May 2019 at 09:00. Participants include all MEs and Departments.
3. Environmental Health will conduct environmental awareness education in the surrounding area where there is clean up.
4. Pikitup to distribute refuse bags, gloves.
5. City Parks to cut grass and trim the trees.
6. JRA to repair potholes and KIB and unblock storm water drains in Identified areas.
7. JPC to assist communities who want to utilise the clean spots.(Adopt a spot)
8. City Power to assist in removing illegal connections and repair street lights.
9. RD to facilitate a meeting with Provincial Government regarding provincial government owned spaces.
10. Ward Governance to invite Councillors
