In terms of Section 127 of the Municipal Finance Management Act (MFMA) 56 of 2003, the City Of Johannesburg's Annual Report for the 2021/22 financial year was tabled before the ordinary Council meeting on Wednesday, 22 February 2023. Council referred the 2021/22 Annual Report to the Municipal Public Accounts Committee (MPAC) for formal consideration. It is now available for public comment.

In terms of Section 127(5) of the MFMA, members of the public and interested organisations are invited to make written submissions on the 2021/22 Annual Report of the City and its Municipal Owned Entities. All submissions should reach the Committee by within 30 days of this publication.
