NOTICE IN TERMS OF SECTION 33(1) OF THE LOCAL GOVERNMENT MUNICIPAL FINANCE MANAGEMENT ACT, NO. 56 OF 2003 AND PART 3 OF CHAPTER 4 OF THE MUNICIPAL FINANCE MANAGEMENT ACT: MUNICIPAL ASSET TRANSFER REGULATIONS 2008
