## **1. BACKGROUND**

In pursuit of its vision to become a global city, the City of Johannesburg (CoJ) acknowledges the need to accustom itself with the prevailing global geopolitical trends, with a view to understanding the influence of such factors as geography, economics, and demography on the city's politics. The City recognises that the impact of factors such as globalisation, climate, topography, demography, natural resources, trade and financial integration, amongst many, are critical to its economic growth.

In search of economic growth, the South African economy has expanded its reach to the rest of the continent, and beyond. The country's deliberate and upward trajectory of developing new markets has heightened its exposure to new and unsettling geopolitical shifts. There is need to match the expansionist thrust of the country's economic strategy with a thorough appreciation of the geopolitical factors. In as much the foreign policy of the Government of South Africa must constantly address emerging geopolitical trends, it is equally imperative for CoJ, as the country's economic hub and foremost contact point for any impact of geopolitical shifts and trends, to develop and maintain a profile of the factors at play.

A grasp of the prevailing geopolitical trends will inform the city's strategy towards world class status, including the establishment of new markets; participation in continental and global networks; and providing a robust basis for benchmarking against leading cities. Individually or combined, different geopolitical factors pose new risks and uncertainties, and have an influence on economies, identities, religion, minorities, quest for resources, technological revolutions and demography among other factors, including having an impact on regional imbalances. Ultimately, the CoJ will be able to minimise negative consequences on its economy caused by the dynamism characterising the global economic and political architecture.

## **2. OBJECTIVES OF THE STUDY**

Group Strategy, Policy Coordination and Relations (GSPCR) would like to appoint a service provider to develop a position paper on geopolitical factors and related shifts, alliances and their impact on the City. The objectives of the position paper are as follows:

- To identify and provide an understanding of the prevailing geopolitical factors that may affect South Africa in general, and the CoJ in particular
- To provide a projection of the magnitude and direction of the impact of the identified geopolitical factors
- To provide focus and structured response to the CoJ's strategy to navigate the identified geopolitical landscape towards positioning the city as a gateway into Africa

## **3. EXPECTATIONS FROM THE SERVICE PROVIDER**

The Service Provider will be expected to develop a position paper on geopolitical shifts, alliances and their impact on the CoJ. Through the position paper, the Service Provider will inform the CoJ of the prevailing geopolitical factors and their profiles, to enable the development of a coordinated response that complements the City's international relations policy. The Service Provider's output should also provide a basis for positioning the CoJ as the gateway to the continent, enabling it to harness foreign direct investments.



#### 4. SCOPE OF WORK

To ensure successful delivery against this assignment, and to produce a comprehensive position paper, there is need to undertake the following;

3.1. *Conducting desktop and secondary research to establish the following key issues:*

- 4.1.1 The comprehensive list of domestic; regional and continental; and global geopolitical factors with a bearing on the CoJ in the short, medium and long terms. These may include, but are not limited to poverty, coalition politics, environment, terrorism, migration, piracy, digital distribution of content, and regulation of modern communications, including the Internet.
- 4.1.2 The anticipated or observed profile for each of the identified geopolitical factors, identifying how they are likely to impact the CoJ
- 4.1.3 Mapping of the CoJ's current response to the identified geopolitical factors, and an assessment of the effectiveness of the responses
- 4.1.4 Mapping of South Africa's current response to the identified geopolitical factors, and how this impacts or benefits the CoJ
- 4.1.5 Mapping of a benchmark country's current response to the identified geopolitical factors

3.2. *Based on the outputs from the preceding task, recommending the following;*

- 4.2.1 Structured approach, response or mechanism to domestic geopolitical factors
- 4.2.2 Structured approach, response or mechanism to regional, continental and global geopolitical factors

#### 5. PROJECT DELIVERABLES AND TIMEFRAMES

The following is expected from the Service Provider:

##### 5.1 Project Deliverables

- 5.1.1 Documentation of domestic, regional/continental and global geopolitical factors and their respective detailed profiles including tables, charts, and maps, etc.
- 5.1.2 Documentation of CoJ and South Africa current responses to identified geopolitical factors, and assessment thereof
- 5.1.3 Documentation of best practices by benchmark country
- 5.1.4 Documentation of recommended structured approach/response to identified geopolitical factors for CoJ
- 5.1.5 Hard and soft copies of all submissions, including a formal presentation of the formal outputs
- 5.1.6

##### 5.2 Timeframes

- 5.2.1 The entire scope of work should be completed within **three (3) months** after the awarding of the contract. A detailed joint schedule plan should be developed with the City's project manager to indicate how the project will be executed from initiation to completion, inclusive of monthly meetings with the project manager

- 5.2.3 Monthly progress meetings in line with agreed work plan, or as and

when required by CoJ
