1. OVERVIEW OF TRAINING

Group Risk and Assurance Services (GRAS) is one of the key corporate governance functions that is there to support the City to achieve the objectives and strategies that will be defined for the organisation.

In terms of IIA Standard 1230; internal auditors must enhance their knowledge, skills, and other competencies through continuing professional development.

In the Past Financial Year, the Auditor General of SA raised 77 Procurement and Contract Management related audit findings (which are recurring each financial year) which are significantly contributing to billions (Rands) of Irregular Expenditure and has material effect on AGSA audit opinion.

Further, Council has subsequently resolved that all Tenders above the value of R5 Million should be subjected to a Probity Audit. In some instances Internal Audit is requested to provide advice on probity matter. This training will assist in sharpening the skills of the Internal Auditors to conduct such reviews.

A probity service is the provision of probity advice to ensure that procurement is conducted fairly and in accordance with Supply Chain Management (hereafter "SCM") Policies and applicable Regulations. It is a risk management tool designed to enhance the integrity of the procurement process.

2. THE EXPECTED OUTCOMES

Upon completing the course, participants must have a comprehensive understanding of how to execute an effective procurement audit and probity audits (advisory & assurance), which are to provide:

- Independent assurance on the reliability, integrity and completeness of the bid specifications;
- Independent assurance of the competitive bid process to ensure that prescribed processes are complied with and that no party is given an unfair advantage or is unfairly discriminated against;
- Provide a on advice concerning probity issues which may be raised during the audit;
- Interim reports throughout the audit and a final report at the end of the audit which records an independent professional assurance of the manner in which it was

managed, from a probity perspective. The final report should be submitted to the EAC;

- This also includes considering the efficacy of proposed solutions for probity related issues which arise during the competitive bid process and investigate any probity issues raised by bidders throughout the process;

3. SCOPE OF WORK

The details on the nature of services are in the specifications section. Below are the key aspects that must be covered under the Supply Chain Management audit training:

- Training on procurement management
- Training on contract management
- Training on probity advisory and audit
- Training on supplier performance

4. TRAINING TEAM PROVIDER REQUIRED

- a) The Training Provider should at least have five (5) years' experience on the provision of training on:
 - i. Probity advisory and/ or probity audit,
 - ii. Procurement management (Supply chain management)
 - iii. Contract management
 - iv. Service provider performance management
- b) The project leader should at least have five (5) years' experience and a NQF Level 8 in above similar fields.
- c) The team leader(s) should at least have five (5) years' experience in the above required training field and must have an NQF level 8 related qualifications.

5. SPECIAL CONDITIONS

The successful service provider will be required to sign the security and confidentiality of all information provided by City of Johannesburg and its Municipal Entities through a non-disclosure agreement.

6. EVALUATION CRITERIA

Proposals will be evaluated on the two stages competitive evaluation process:

Evaluation Criteria

- 1) Bids will first be evaluated and scored on the functionality elements. Only those bidders that meet the minimum threshold of 70% shall be considered for the subsequent stages of the evaluation process and all bidders who did not meet the minimum threshold shall not be considered for further evaluation.
- 2) Bids that meet the minimum threshold shall be evaluated in terms of the 80/20 preference points system, wherein 80 points will be allocated for price only, and 20 points for BBEE.

The evaluation criteria for functionality are set out in **Table 1** while the evaluation criteria for the 80:20 points in respect of the revised Preferential Procurement Regulations, 2017 are set out in **Table 2**.

The below indicate points will be used in for evaluation criteria.

STAGE 1: Functionality evaluation will be based on previous experience and expertise on related or similar projects and re-sourcing (capacity, availability, accessibility, and timing). The following criteria will be applicable and the maximum weights of each criterion will be as indicated.

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
