1 STRATEGIC THRUST

2 PURPOSE

The Group Communication and Marketing Department wishes to procure a suitably qualified service provider to assist the City of Johannesburg with media monitoring for a period of three (3) months.

The purpose of this document is to invite proposals from suitably qualified service providers for the provision of the three (3) month media monitoring service.

3 OBJECTIVE

The media monitoring service has the following objectives: -

- Measuring the overall reputation of the City of Johannesburg; and
- Monitoring the media coverage of the City's business/mandate.

4 SUMMARY

4.1 Background

The Group Communication and Marketing Department is entrusted with issues of reputation management, strategic communications, events management and integrated marketing.

To ensure that adequate communication, media relations, public relations and stakeholder relations occur in the interest of active and engaged citizenry, and to also reduce the information gap that exists in the communities of Johannesburg, the department is required to enlist the services of a media monitoring company to provide a comprehensive media monitoring, analysis and trending service to the City of Johannesburg, including its municipal entities.

5 SCOPE OF SERVICE AND DELIVERABLES

The service should monitor stories relating to the City of Johannesburg, the City's seven regions, the municipal-owned entities (i.e., City Power, Joburg Water, Pikitup, Johannesburg Roads Agency, Johannesburg Development Agency, Johannesburg Property Company, Joburg City Parks and Zoo, Joburg City Theatres, Joburg Market, Metrobus and Johannesburg Social Housing Company), the Joburg Ombudsman, including relevant legislations, speeches, major events hosted in/by association with the City of Johannesburg (Joburg) and the Johannesburg Police Department (JMPD), Emergency Management Services (EMS), and Rea Vaya.

Service providers are thus required to quote on the following deliverables, namely:

- Daily monitoring of print (newspapers and publications), online (websites) and electronic/broadcast media (TV and Radio).
- Daily emailing of print, online and broadcast media coverage reports to fifteen (15) selected communicators.
- Daily emailing of press clipping and audio visuals.
- Analysis of community, national, continental and international media coverage (print, online and electronic).
- Monitoring of magazines, newspapers, online and broadcast media.
- Provide, maintain and update online archiving facility (with a password) for access of media coverage and reports by the City.
- Monthly and quarterly reports and analysis on coverage (print, electronic, online and broadcast) for the city and AVE (which refers to the cost of buying the space taken up by a particular article, had the article been an advertisement).
- Archiving of all media coverage and reports.
- Media analysis to be tracked as to which reporter, which portfolios and which publications are generating the most negative and positive publicity monthly (percentage of favourable, positive and negative publicity monthly).
- Back search articles from 1 February 2021.

6 MINIMUM REQUIREMENTS: EXPERIENCE & SKILL

Bidders are required to demonstrate the following in their submissions/proposals:

- 6.1 **Company experience** – At least five (5) years’ relevant media monitoring and analysis industry experience.
- 6.2 **Company track-record** – Bidders must have a proven track-record in media monitoring, media trends and media analysis with at least three (3) successfully completed media monitoring contracts for different companies and/or government departments with contactable references.
- 6.3 **Qualifications** – Bidders are expected to have in their teams the following expertise: media trend analysis, media monitoring, media analysis and communication/public relations or related fields. All key personnel to hold a qualification in either Communication, Media Monitoring and Research, Public Relations or Marketing.
- 6.4 **Individual team experience** – The combined team should be led by a dedicated Project Leader/Key Account Manager with three (3) years’ or more experience (attach detailed CV of the Key account Manager / Project Lead outlining experience) with at least two (2) or more additional qualified individuals (attach CVs demonstrating between 2-3 years’ experience in respect of each team member).

Disclaimer:

The contract requires five (5) years’ company experience and a dedicated Key Account Manager because of the largeness of the City of Johannesburg account.

7 EVALUATION CRITERIA

Proposals will be evaluated on price and experience on having conducted media monitoring and analysis as per set scope above. Bidders that achieve a threshold of **60** points will proceed for price evaluation.
