**INTRODUCTION****1.1. BACKGROUND**

The City of Johannesburg has seventy-nine (79) health clinics that provide comprehensive primary health care services to the community. To provide comprehensive primary health care services several resources are needed that include amongst others Medical Oxygen. Medical Oxygen is amongst the most vital and essential items required in a clinic, in the sense that a clinic cannot operate without medical Oxygen. The clinics is often the first port of call, when people need medical attention including emergency, due to various reasons such as easy accessibility and affordability.

**2. SCOPE OF WORK**

The Health Department requires Medical Oxygen to be delivered at all clinics as well as the collection of empty cylinders.

The service provider shall supply and delivery of Medical Oxygen to the City of Johannesburg for a period of 5 months.

The following is therefore required:

- Placing of orders for the supply of Medical Oxygen
- Delivery of Medical Oxygen by the company as per the order
- Collection of empty cylinders when a full cylinder is delivered
- Monthly invoicing of services rendered within that month
