3. Quotations are to remain open for acceptance for a period of thirty (30) days effective from the date on which they are lodged and shall be accepted at any time within the said period of thirty (30) days.
4. In the event of a mistake having been made on the price schedule it shall be crossed out in ink and be accompanied by an initial on each and every price alteration. Corrections in terms of price may not be made by means of a correction fluid such as Tipp-Ex or a similar product. If correction fluid has been used on any specific price item, such item will not be considered. No correction fluid may be used in a Bill of Quantities where prices are calculated to arrive at a total amount. If correction fluid has been used, the whole quotation will not be considered. The entity will reject the quotation if corrections are not made in accordance with the above.
5. No price increases/adjustments will be considered.
6. All purchases will be made through an official purchase order form; therefore, no goods must be delivered or services rendered before an official purchase order has been forwarded to and accepted by the successful bidder.

10. All prices quoted must be inclusive of Value Added Tax (VAT). Suppliers who are not registered for VAT will be treated as Non - VAT Vendors.
11. All prices submitted must be firm. "Firm" prices are deemed to be fixed prices, which are only subject to the following statutory changes, namely VAT and any levy related to customs and excise.
12. All prices and details must be legible/readable to ensure the quotation will be considered for adjudication.

1. INTRODUCTION & OVERVIEW

The Joburg Tourism Company (JTC) is a destination management organisation (DMO) of the City of Johannesburg, dedicated to promoting the destination's tourism growth. Its primary function is to promote Joburg as a business, lifestyle, sport and leisure destination. Its operations include coordinating city-wide tourism marketing programmes, tourism information gathering and analysis.

As a DMO, Joburg Tourism plays a leading role in facilitating partnerships with various authorities, stakeholders and professionals to achieve a unified mission to create targeted communication that connects business and leisure travellers to Joburg, one experience at a time.

Johannesburg is competing with other leading and emerging destinations for the global tourism market share. The inherent risk of a potential threat in the decline of tourist/visitor numbers to Johannesburg thus requires aggressive marketing interventions to remain top-of-mind, maintain/grow market share, consistently build traveller confidence and attract new visitors. Amplifying destination marketing to promote Johannesburg as a diverse, year-round business, lifestyle, sport and leisure destination to grow the number of visitors and tourist spend is, therefore, an imperative in the fulfilment of the DMO mandate.

Hence the entity is embarking on this request for quotations from qualified creative agencies to conceptualise, develop, manage, and execute an immerse *Welcome2Joburg* digital campaign for a period of three (3) months from date of appointment.

2. PROJECT BACKGROUND

The Joburg Tourism Company (JTC) seeks to strengthen Johannesburg's positioning as a premier African destination by promoting its diverse cultural experiences, attractions, lifestyle, and business opportunities. The *Welcome2Joburg* campaign is a flagship brand initiative designed to invite both international and domestic visitors to discover the city's vibrancy, creativity, and people.

To amplify this brand, JTC intends to implement a fully integrated, immersive digital campaign that includes personalised visitor touchpoints, user-generated content promotion,

and influencer-led storytelling. This request for quotes outlines the strategic, technical, and creative requirements for the delivery of the campaign.

3. OBJECTIVES

The *Welcome2Joburg* campaign aims to:

- Enhance the visibility and emotional resonance of the destination brand.
- Provide personalised, seamless digital experiences that support visitor orientation and trip planning.
- Drive user-generated content (UGC) to increase organic reach and authenticity.
- Collaborate with influencers and partners to expand the city's digital footprint.
- Increase visitor engagement, dwell time, and digital conversion.
- Strengthen Joburg's reputation as a vibrant, culturally rich, safe, and welcoming city.

4. SCOPE OF WORK

The Immersive Digital Campaign consists of **three major activation pillars**:

4.1. Activation 1: FindYourJoburgJoy with Uber

Purpose: Create a welcoming, personalised digital arrival experience for visitors at OR Tambo International Airport.

4.1.1 Requirements

- Collaborate with Uber South Africa and relevant partners to integrate a *Welcome2Joburg* takeover within the Uber app for users opening the app at geofenced zones.
- Design and upload a "Welcome2Joburg" app banner including visuals, copy, and multilingual welcome message.
- Develop a system that provides personalised experience recommendations, including:
 - Rooftop bars and nightlife
 - Restaurants and culinary hotspots
 - Hospitality accommodation offers
 - Attractions, museums, galleries
 - Adventure and nature activities
 - Lifestyle and sporting events

- Provide analytics tracking:
 - User impressions
 - Engagement and social sharing using **#Welcome2Joburg** and **#FindYourJoburgJoy**
- Ensure compliance with POPIA and data privacy guidelines.

4.2. Activation 2: ShareYourJoburgJoy (User-Generated Content Campaign)

Purpose: Encourage visitors to share authentic personal experiences that amplify Joburg’s story through real voices.

4.2.1 Requirements

- Develop and launch a **User Generated Campaign (UGC) competition** across Joburg Tourism Company social channels (Facebook, Instagram, TikTok and X).
- Create compelling promotional assets (videos, banners, copywriting) encouraging users to share:
 - Travel photos
 - Short videos
 - Stories about their time in Joburg
- Use branded hashtags **#Welcome2Joburg** and **#ShareYourJoburgJoy**, with a tracking mechanism (dashboard or aggregator).
- Coordinate with hospitality, attractions, and tourism partners to secure prize packages, such as:
 - Weekend stay at accommodation facilities in Joburg
 - Adventure and or cultural experiences
 - Curated lifestyle packages (gastronomy, events etc.)
- Administer judging criteria and selection process.
- Showcase winning entries across digital platforms (Visit Joburg platforms), giving credit to creators.
- Provide monthly insights on participation, reach, sentiment, and UGC trends.

4.3. Activation 3: Joyful Journeys Influencer Campaign

Purpose: Expand reach and credibility through curated storytelling led by influencers and travel creators.

4.3.1 Requirements

- Identify and contract **influencers** across domestic markets (lifestyle, travel, culture, food and adventure).

- Plan hosted experiences, itineraries, and storytelling themes to reflect Joburg’s diversity.
- Provide influencers with guidelines on:
 - Campaign tone and brand identity
 - Mandatory messaging points
 - Use of hashtags **#Welcome2Joburg** and **#FindYourJoburgJoy**
- Produce a package of high-quality content:
 - Videos (YouTube, TikTok, Reels)
 - Photo stories
 - Behind-the-scenes experiences
- Publish content across JTC’s owned channels and influencers’ platforms.
- Track:
 - Engagement
 - Reach and impressions
 - Traffic referred to Visit Joburg digital platforms, i.e. FaceBook. Instagram, X, YouTube, TikTok and LinkedIn
 - Content performance on the digital platforms for the period of three (3) months

5. Deliverables

The service provider(s) must deliver:

1. **Campaign Plan and Creative Concept**
 - Full digital campaign framework
 - Creative direction, tone, storyline, and visual identity
2. **Activation-Specific Deliverables**
 - Uber App integration assets & technical setup for the three (3) months
 - UGC competition rollout pack for the three (3) months
 - Influencer tactical content plan for the three (3) months
3. **Content Production for:**
 - Social media content scheduling and management platform (to be shared with Joburg Tourism digital media team) and monthly analytics reports.
 - Social media campaign strategy in line with the immersive digital campaign.
 - Social media content calendar/plan for the period of three (3) months.
 - Creative development (graphics and 30 second videos) and execute social media campaign activities i.e. post on Facebook, Instagram, X, TikTok, YouTube and LinkedIn once a week for the duration of the contract.

4. **Campaign copywriting:** persuasive writing, consistent, and targeted messaging for communication campaign for the period of three (3) month on:
 - All social media posts (Facebook, Instagram, X, YouTube, LinkedIn, TikTok)
 - 3 x Campaign posters per week for the duration of three (3) months on social media platforms
 - 3 x 30second video scripts in line with immersive digital campaign for business, leisure, events
5. **Campaign Management**
 - End-to-end execution of digital activations
 - Influencer liaison and contracting
 - User Generated Content moderation and engagement
6. **Analytics & Reporting**
