1. STRATEGIC THRUST

Good governance

2. BACKGROUND AND INTRODUCTION

Successful organisations recognise the importance of strategic planning session as it is geared to improving its business operations.

These sessions are focused at reflecting performance, areas of improvement, forward planning, subsequently ensuring the implementation of resolutions and a development of an action plan.

The City operates in a global context / market, whilst changes occurs at an unprecedented pace, under stringent government legislation/ controls with the desire of being “ *If Joburg works, South Africa Works*”.

In keeping abreast of its service delivery agenda the City convenes its strategic planning sessions to monitor progress against set priorities of the new administration and channel the resources wisely in this changing environment and align all initiative’s that will assist the organisation achieve its long term objectives.

Furthermore, the need to consolidate achievements and evaluate impact of projects ensuring objectives set at the beginning of the new administration.

3. SCOPE OF WORK

Subsequent to the Local Government elections 03 August 2016 the new administration under the leadership of Executive Mayor, Councillor Herman Mashaba, he without any waste of time outlined a 10 point plan and the 9 key priorities which are geared towards giving effect to the expressed commitment to declare war on corruption. To this end, he declared corruption to be public enemy

no.1. The Executive Mayor further pronounced the establishment of a new unit that will fight fraud, corruption, theft and maladministration in the City. As a result, the Group Forensic Investigation Services (GFIS) was established under the leadership of Commissioner Shadrack Sibiya.

In giving effect to the above mentioned pronouncement, GFIS is expected to develop an anti-corruption strategic framework and implement programmes in support of the City's strategic objectives. This will serve as a roadmap to guide and support all Departments (within the City) and Municipal Entities to deal with issues of fraud, corruption, theft and maladministration on a day to day basis.

The GFIS is of the firm view that it is the responsibility of every employee within the City, including Councilors and its residents to contribute to the fight against corruption in order to ensure a corrupt free City. A consultative approach with all key internal and external stakeholders has been adopted to join hands to tackle the scourge of corruption and maladministration that has a significant impact on service delivery.

4. THE ROLE OF THE CONSULTANTS WILL BE:

Consultants will be responsible for the following tasks:

- To attend a compulsory briefing sessions with senior management of the Group Forensic and Investigations unit.
- Advise the organization on the process of the workshop.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
