## 2. BACKGROUND AND INTRODUCTION

In terms of section 121(1) of the MFMA, every municipality and municipal entity must prepare an Annual Report for each financial year. The purpose of the Annual Report is to provide a record of activities, report on performance against the budget and promote accountability to the local community for the decisions made throughout the year.

The Group Governance department assists entities and the Group to adhere to good governance practices in the City of Johannesburg. This is to ensure that Johannesburg becomes a world class African City of the Future – a vibrant, equitable African City that is strengthened through its diversity and a City that provides sustainability for all its citizens, a resilient and adaptive society.

Municipal Owned entities find themselves in a unique operating environment whereby over and above preparing an Integrated Report in accordance with the <IR> Framework, they are still expected to comply with various prescriptive legislation such as King III, Municipal Finance Management Act (MFMA) Circular 63, Municipal Systems Act (MSA) and Companies Act. As a result, entities may find it increasingly challenging to prepare a report that encompasses all the Guiding Principles as per the <IR> Framework.

In 2012/13 financial year the City of Johannesburg enlisted the services of Nkonki to conduct an independent assessment of 11 entities' Annual Reports, in 2013/14 and 2014/15 the City appointed Ramuedzisi Advisory Services and Grant Thornton South Africa (GT) respectively to provide a concurring view. One of the recommendations from GT was that a workshop with individuals within the MOE's who are responsible for preparing, coordinating and compiling the Integrated Annual Reports, the Company Secretaries and Group Governance assessors should be convened and the affected parties trained and given guidance on how to prepare and compile a truly Integrated Report.

## 3. OBJECTIVE

The objective of the Workshop is to train City of Johannesburg officials who are responsible for compiling and/ or assessing Integrated Reports of the entities and Group. Officials would be trained on how to produce an Integrated Report that truly conforms to International Integrated Reporting Framework (<IR>), MSA, MFMA, King IV and Circular 63 of MFMA requirements.

- ✓ An IR is a concise communication about how an organisation's strategy, governance, performance and prospects, in the context of its external environment lead to the creation of value over the short, medium and long term.
- ✓ The primary purpose of an integrated report is to explain how organisation creates value over time. It therefore contains relevant information, both financial and other.
- ✓ An integrated report benefits all stakeholders interested in an organization's ability to create value over time, including employees, customers, suppliers, business partners, local communities, legislators, regulators and policymakers.



- ✓ Integrated reporting is based on two fundamental and interconnected concepts: value creation and capitals

#### **4. SCOPE OF SERVICES OF FACILITATOR**

- 4.1.** Facilitator must be a seasoned Integrated Reporting Specialist, preferably a qualified Chartered Accountant who has at least 5 years' experience in preparing the Integrated Annual Report in accordance with the International Integrated Reporting Framework, Circular 63 of MFMA, Municipal Systems Act, MFMA and King III on Corporate Governance.
- 4.2.** Facilitator must in consultation with Group Governance design a process plan for facilitating the workshop to generate the agreed outputs.
- 4.3.** Explore strategic issues identified from previous Integrated Annual Report Assessments and provide solution to challenges identified.
- 4.4.** Prepare a detailed report with recommendations to Group Governance on strategic issues in support to key decisions of improving Integrated Reporting application within Municipality Owned Entities and the Group. The report should be in a form of a report and presentation.

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No. 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No. 12 of 2004 or any other applicable legislation.
